The Zimbabwe Stock Exchange Limited ('ZSE') has adopted the Global Industry Classification Standards ("GICS"). All ZSE listed counters will be reclassified according to this framework with effect from 01 January 2020 as follows:

 - vii. ZSE Real Estate Index
- 8. Top 10 Investable Index
- 9. ZSE Export and Dual Listed Index

*The current Industrial Index will be discontinued and redefined according to GICS while the Top 10 Investable Index will account for free float adjustment. The new indices are expected to provide the market with better tools for performance measurement as well as assist in sector-based investment strategies. As an example, a fund manager will be able to create a portfolio that focuses on investing in export and dual listed stocks and offer such portfolio as a unit trust to potential investors.
