## ZSE TRADING HOURS DURING LOCKDOWN (29 MARCH TO 19 APRIL 2020)

His Excellency, the President of Zimbabwe declared Covid-19 a national disaster followed by a 21 day lockdown effective 30 March 2020 to 19 April 2020. After consultation with the Ministry Of Finance and Economic Development ("MoFED") and The Securities and Exchange Commission of Zimbabwe ("SECZ"), the Zimbabwe Stock Exchange Limited ("ZSE") will continue trading during the lockdown under the following conditions;

1. The trading hours will be shortened as follows as previously communicated;

- 2. The ZSE will be closed to all outside visitors during this period. We therefore encourage our stakeholders to interact with us through email and our social media platforms.
- 3. Skeletal staff will be manning the office, therefore the ZSE reception will be closed during this period. For any assistance the following personnel will be on standby;

- 4. Work attendance registers for the personnel on duty will be submitted to the MoFED, Human Resources, Administration and Finance Departments every Friday at 16:00 hours, through the following email addresses; hrzimtreasury@gmail.com, vereir@gmail.com, and esquiredube@gmail.com
- 5. The following protocols will be adhered to by all members on duty:
  - Frequent sanitization when going in and out of the premises;
  - To maintain a distance of at least 2 meters from the next person at all times;
  - Frequent disinfection of surface areas;
  - Wash hands thoroughly for at least 20 seconds with soap and running water;
  - When coughing or sneezing cover mouth and nose with tissue or flexed elbow;
  - Avoid close contact with people who are coughing or sneezing.
  - Reminders of these critical hygiene habits will be communicated on a regular basis and displayed on every entrance and exit point.
  - 6. Any member of staff showing Covid-19 symptoms will immediately be isolated and guidance will be sought from health authorities.
  - 7. A register of personnel working at the ZSE during this lockdown will be submitted to the MoFED on Monday 30 March 2020.
  - 8. All ZSE market participants that will be working from their offices are required to observe similar measures including reporting to the MoFED.

We encourage everyone to take the necessary precautionary measures and be vigilant during these trying times.
