ABOUT THE DEPOSITORY

A Central Securities Depository (CSD) is an electronic register of securities such as shares, bonds, derivatives, Exchange Traded Funds.

The main functions of the CSD includes the deposit and withdrawal of securities, clearing and settlement of trades, safekeeping of securities and management of corporate actions.

The ZSE Depository started its operations in October 2021, and its main responsibility is the operation of the Central Securities Depository, (CSD).

As at 30 September 2022, the ZSE Depository has a total number of 14, (fourteen) issuers, four of which are Exchange traded funds.

The ZSE depository has the responsibility for recommending entities to be admitted as depository participants on the ZSE. The participants are clearing members whose role is to perform the clearing function on behalf of the ZDE depository.





• The average Demat ratio for the counters on the VFEX depository as at 30 September 2022 was 75.59%





BROKER CONTROLLED ACCOUNTS

- Nine brokers have managed to sign the tripartite agreement between CBZ Bank, VFEX Depository and stockbroker. To date eight stockbrokers have been boarded onto the EDS system.
- The brokers being Akribos Securities, IH Secuities, Morgan & Company, Old Mutual Securities, Invictus Securities, Lynton Edwards Stockbrokers, Imara Edwards Stockbrokers, Jemina Capital and Wealth Access.
- The broker controlled accounts have been trading and with 54 trades to date, and the majority being on the sell side.
- About 30 new accounts have been opened to date
- All the trades have been settling through CBZ and we have not had any settlement challenges to date
