The ZSE offers a broad range of products and services comprising of Equities, ETFs, REITs, fixed income securities, data and training services

### VFEX

The VFEX is positioned as a pivotal offshore financial services hub, catering for local and international investors.

- The ZSE recorded a total market turnover of ZWG 5.62 Billion in 2025, representing a 146.96% increase from 2024.
- The closing total market capitalisation for 2025 stood at ZWG 91.62 billion, an increase of 34.29% from the previous year.
- The ZSE All Share Index closed the year at 277.86 points, a gain of 27.7% from the closing 217.58 points in 2024.
- Foreign investor participation decreased to 20.96% in 2025 from 24.68% in 2024.

## 2025 Indices Performance


- The ZSE All Share Index, which is the measure of the overall market performance, closed the year at 277.86 points, a gain of 27.70% from 2024.
- The ZSE top 10 Index, which is the blue-chip index on the ZSE, gained by 30.91 % from 215.24% in 2024 to 281.78 points in 2025.
- The ZSE Consumer Discretionary Index recorded the highest gains in 2025, registering a 125.57% gain from 333.62 points to close at 752.55% points.



- 2025 recorded a turnover figure of ZWG 5.43 billion on the Equities board representing 96.46% of the total turnover.
- **The top five traded companies during the period under review were:**
  - ECO.ZW (ZWG 2.237 billion)
  - DLTA.ZW (ZWG 2.019 billion)
  - NMB.ZW (ZWG 314 million)
  - CBZ.ZW (ZWG 218 million)
  - TIG.ZW (ZWG 194 million)
- The total turnover for the top 5 companies contributed 88.61% of the total market turnover for the period under review.


- The chart below shows the turnover contributions for 2025.





## EXCHANGE TRADED FUNDS

- As of the close of 2025, ZSE had four ETFs listed.
- One ETF (OMTT.zw) was delisted in January 2025.
- The ZSE ETF Index declined by 7.32% to close the period under review at 455.87 points.
- The ETF board recorded a total turnover value of ZWG 4.23 million in 2025.
- In 2025, a total of 28.92 million ETF units were traded on the ZSE.
- Market capitalisation for ETFs stood at ZWG 116.61 million as at 31 December 2025, representing a 67.40% decline from ZWG 356.63 million in December 2024.
- This decline was largely driven by the delisting of the Old Mutual Top Ten ETF.




The graph highlights the overall movement of the **ETF Market capitalisation** from April 2024 to December 2025

## REAL ESTATE INVESTMENT TRUST (REITS)

- The ZSE currently has two REITs listed namely Tigere REIT and Revitus Property Opportunities REIT.
- At the close of 2025, the ZSE REIT market had a market capitalization of ZWG 4.25 billion, reflecting a robust 160.74% increase from ZWG 1.63 billion in December 2024.
- In 2025, the REIT board on the ZSE recorded a total traded value of ZWG 194.68 million, reflecting an 8.87% decrease from ZWG 178.82 million in the previous year.
- The ZSE saw 154.75 million REIT units traded during 2025, a decline of 41.98% compared to the 266.71 million units traded in 2024.

## EQUITIES MARKET CAPITALISATION

- The ZSE's market capitalization stood at ZWG 87.26 billion on 31 December 2025, marking a substantial 31.73% increase from the prior year's close of ZWG 66.24 billion.
- The top five biggest equity contributors to market cap were;
  - DLTA.ZW contributed 31.83%
  - ECO.ZW contributed 21.05%
  - FBC.ZW contributed 9.59%
  - CBZ.ZW contributed 6.89%
  - RTG.ZW contributed 4.12%

# 2025 VFEX HIGHLIGHTS



## 2025 Market Highlights

- Total value traded increased from US\$56.94 million in 2024 to US\$111.05 million in 2025, representing a 95.02% increase.
- The VFEX All Share Index rose from 104.08 points in 2024 to 177.12 points as at 31 December 2025, representing a 70.18% increase. Notably, 2025 recorded the highest VFEX All Share Index level since rebasing.
- VFEX market capitalisation grew from US\$1.28 billion in 2024 to US\$2.1 billion in 2025, reflecting a strong 63.89% increase.
- In 2025 the VFEX had 2 new listings, that is Kavango Resources Plc and the Eagle Real Estate Investment Trust


## INDEX PERFORMANCE

- The VFEX All Share Index delivered an exceptional performance in 2025. The index rose from 104.08 points in 2024 to 177.12 points as at 31 December 2025, representing a 70.18% increase.
- Notably, 2025 recorded the highest VFEX All Share Index level since rebasing in January 2024, reaching a peak of 179.52 points during the year.




